CENTRAL COMMITTEE MEETING CONDUCTED AT NAGPUR, OUR DEEKSHA BHOOMI – AT NAGLOKA ON 26-05-2018 & 27-05-2018.

The Central Committee Meeting of our beloved Association was convened on 26th & 27th May 2018, at 11.30 at Nagloka, Nagpur as per Bye law 6 of our Association, once in 6 months. Majority of the Central Committee members from all over the country attended the meeting, i.e. 73 out of 114 attended the meeting, 17 were on leave and 24 were absent.

The meeting was Presided/Chaired by Sri S THANGARAJU, Senior Vice President, in the presence of Sri A SIVAJI, General Secretary, Sri B D Teddiwadi Vice President, Sri M. Subramanian Vice President, Sri R N Munda Vice President, Sri Vinod Kumar Vice President, Sri H Thippeswamy COS and all Deputy General Secretaries & Joint Secretaries.

In the absence of Sri Somraj President Sri S Thangaraju, Senior Vice President presided over the CC meeting and conducted the proceedings as per bye law 6, C. The General Secretary congratulated all the Central Leaders who are actively working in the circles for the Welfare of Members mainly Transfers, Charge Sheets, redressal of grievances

In the absence of The Treasurer, Sri Thippeswamy Chief Organizing Secretary briefed the CC Members about the accounts and requested for approving the bills. Since many of the Central Office bearers sought for clarifications, shortage in reimbursement of bills and non payment of advance amount for branch visits and even for the CC meeting of Nagpur, the approval of bill matter has been kept in abeyance.

The Central Committee conveyed their sincere Thanks to Leaders Sri S A Bokede, DGS, Sri Rangla Naik Joint Secretary, Sri Viswambaram, Joint Secretary, Sri Naresh Kumar Joint Secretary, Sri. Gopal swamy CC Member, Sri K P Subramaniam CC Member, for their continuous services to our Association and retired from the Services on superannuation. The request of the CC Members who have submitted resignation was accepted. Those who went on promotion to the next circle and requested for resignation was also accepted. Those who have not attended THREE consecutive CC meetings forfeited their CC Member post as per bye law 6 (G) p. 14 and the Central Committee has approved the same.

The following agendas were discussed in detail, decisions were taken as follows and passed resolutions for the Welfare of our members :-

1) The Central Committee has unanimously decided to form a Sub-Committee to manage our "**Canara Bank SC/ST Employees Welfare Association benevolent fund**", operated by any TWO of the five office bearers.

4) **Organization/Agitation Activity** :- It was unanimously decided to conduct a demonstration in front of all the Circle Offices and Regional Offices and to start with, in front of Town hall, Bangalore for demanding the management to absorb all the Coolies in the HKP vacancies since majority HKPs are from SC/ST community - as advised by the National Commission for Safai Karamcharis, New Delhi at the earliest. Also it was decided to request Management to conduct the promotion Test for Sub-staff to Clerk in which HKPs are to be included like in other Peer Banks.

It was also decided to request all the SC/ST HKPs to submit a memorandum to the DFS Finance Ministry, New Delhi to intervene, for including HKPs in the Sub-staff to Clerk promotion process.

6) A letter addressed by Sri Somraj, President dated 04-05-2018 to the Chief Organising Secretary, and letter dated 15-05-2018 addressed to all office bearers for cancellation of the Central Committee Meeting, (Officially called by the Chief Organising Secretary as per the Bye Law 6), unilaterally without consulting any office bearers was taken for a discussion. After discussing the same vividly the following decision and action was taken unanimously as per bye law 25 of the Association.

A) The Central Committee unanimously decided to remove the President Sri Somraj from the President post for doing anti-association activities: (1) Letter addressed to COS unilaterally.

(2) Letter dated 15-05-2018 addressed to all office bearers for cancelling the CC meeting which was called by COS as per bye law.(3)Non attending various meetings.(4) Instructed the treasurer not to release the funds to CC Members.(5) Issuing Blank cheques to the treasurer.(6)Creating groups to divide the association with the support of retired employees with an intention to hamper the developmental activities in the Association. The central Committee has also decided to co-opt Sri Somraj as Vice President of the Association.

B) The Central Committee has unanimously decided to Co-opt SRI S THANGARAJU Senior Vice President, as the PRESIDENT of our Association subject to the approval of the next Annual General Body as per bye law 25.B.

C) The central committee has unanimously decided to remove Sri K Kumar from the Treasurer Post as he has connived with the President in doing anti association activities and not allowed to conduct the CC Meeting of Nagpur on 26-05-2018 & 27-08-2018 by not providing advance amount to 90 Central Committee members duly elected in the General Body 2016. The Committee further Co-opted Sri K Kumar as a Joint Secretary of the Association.

D) The Central Committee has unanimously decided to co-opt SRI P GOVINDAPPA as the Treasurer of the Association and in his absence Sri MEESHI NAGARAJ as the Treasurer of our Association.

The Central Committee has taken a democratic decision in order to conduct the association activities smoothly. The Central Committee has also taken a decision to conduct THE ANNUAL GENERAL BODY for ratification of the decisions taken and for smooth functions of the Assn.

The President and the General Secretary has assured the Central Committee Members that they will work towards fulfilment of the aim and objects of the Association with the fullest co-operation of all the Leaders and Members. We also request our Leaders to redress all the grievances of our members and in case of need call us to their Circle and we are ready to reach their circle within 24 hours.

B) OUR ASSOCIATION ACCOUNT 0424 101 015658 AT LONGFORD TOWN HAS BEEN STOPPED BY SRI SOMRAJ, Former President & SRI K KUMAR, Former Treasurer.

We are informed by the Chief Manager of Longford Town branch that our brothers Sri Somraj & Sri K. Kumar have instructed the Longford Town Branch not to permit the operations and Debits in the Account.

We have informed the Central Committee Meeting decisions to the Longford Town branch and also submitted the CC Meetings decisions to the Head Office HR Wing, Bangalore.

In the meanwhile in order to make the Payment towards the Salary of our Assn Employees, Telephone Bill, Electricity Bill and statutory dues we have opened a Joint Account **8693111501130** in the name of Sri S Thangaraj, Sri A Sivaji, Sri H Thippeswamy, Sri Meeshi Nagaraj and requested our Office bearers to remit a little amount to the account so that we can run the Assn smoothly until General Body.

We request all our members to contribute a sum of Rs 100/Rs 200 to the account to conduct the General Body on 15-07-2018 at Bhubaneswar Smoothly.

We request all the Office bearers to visit RSTC on 09-07-2018 and collect the mandates from the NEW POs.
